

# 2019-20 access and participation plan monitoring

# **Provider impact report**

This impact report summarises the progress made by Ravensbourne University London against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

# 1. Ambition and strategy

Ravensbourne University London's ambition and strategy as detailed in the 2019-20 access and participation plan:

To promote social mobility, reflecting the diversity of our local community and enabling change beyond Ravensbourne to the socio-economic profile of practitioners in the creative industries.
To be inclusive, ensuring that every student is able to succeed whatever their background, and to support each individual as best suits their needs.
To contribute positively to maintaining and expanding the pipeline in Creative Industries Higher Education, given the impact of recent changes to school curricula on our subject-areas. The Creative Industries sector is the UK's fastest growing economically, employing 9 percent of the workforce and with an annual worth of £91.8 billion (Government economic estimates for 2015-16).

How have you met the commitments in your plan related to this target?

During 2019-20 we targeted our outreach work at geographical areas identified as low POLAR as well as those identified by the OfS as "opportunity areas." We made links with sixth form schools and colleges in local (commutable) low POLAR4 areas such as Bexley and Dartford, and formalised a progression agreement with a large college in this area, London South East College, that spans Bexley, Greenwich, Bromley and Orpington.

Historically performance against this target has been varied as the true number of students in this target group are difficult to ascertain due to non-disclosure. Furthermore, this is a very difficult demographic to engage with online.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We had planned to run a bespoke summer school for looked after children in 2020, but this wasn't possible due to COVID related lockdown.

How have you met the commitments in your plan related to this target?

We continue to adjust and improve our monitoring of student satisfaction, both overall and at course level, and take our lower-than-expected results seriously.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Additional meetings were held for lower scoring courses, and additional and/or amended targets set, as deemed appropriate to each course. A detailed analysis of students' comments was undertaken at course-level, which allowed for greater scrutizing of results, an investigation into problem areas, and also helped to inform a specific plan of action to address satisfaction for each course. Finally, the Student Union set up a series of online event for students, specifically aimed at addressing areas of concern.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We have moved a number of our programmes online, and launched an additional programme that runs through the academic year. We are seizing the opportunity online programmes present to reach and engage with a larger number of young people, both within and beyond London.

How have you met the commitments in your plan related to this target?

We continue to move towards our ambition of a more long-term, sustained Outreach delivery.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We have focused our efforts on developing and strengthening our online programmes this year. We have launched a new 18 month progression programme called 'Make it Ravensbourne' which we have offered to our existing school, college and outreach partners, as well as targeting this programme to younger audiences that might want to explore and develop their creative skills in lockdown. We are being flexible with our programme of activities and delivery model as covid restrictions are changing.

How have you met the commitments in your plan related to this target?

We have made good progress on the previous year's figure.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Our work in this area has been hugely impacted by COVID related lockdowns, and engagement with learners from our partner schools and colleges has been considerably less since March 2020. We have moved our offer online, and continue to try and engage with young people to provide good quality information, advice and guidance and support them to put together portfolios for university interviews.

Our work continues to develop partnerships with Access courses and work with Mature learners.

We reached out to Access courses in London and the wider UK to form collaborative nextworks that allowed us to engage with their learners through our online 'Make it

Ravensbourne' progression programme of creative workshops, specifically targeted to the Mature learner group. In addition, we continue to invest in a mentoring programme for students studying on Ravensbourne's Access to HE course to ensure they have the skills and confidence to progress to Higher Education.
